### District Receives Second Highest Financial Rating in Upstate NY

The District, like a resident making a home purchase, will need to borrow money to pay for the project. In order to lower the total amount of interest required to be paid out, the District has selected a 15 year payback option vs. a greater number of years creating more interest dollars.

Like the conditions that all families face, their credit rating strongly impacts the interest rate. A financially stronger family or school district will get a lower borrowing rate than a family or school district having financial problems.

The Grand Island Central School
District was last upgraded in July 2008
by Moody's Inc. from A-2 to A-1. In
April 2010, based on our excellent
financial status, the District was again
upgraded two levels to "Aa2". This
is the second highest school district
rating in all of Upstate New York. The
District is very proud to have achieved
this rating and, as a result, District
residents will see a considerable
savings in the cost of borrowing as
compared to many hundreds of other
school districts which need to borrow
for a variety of needs.

## **Absentee Ballot Information**

For those voters who qualify, absentee ballots are available. Of course, there are specific reasons for the use of absentee ballots. To be considered, you must fit one of the following categories:

- Duties, occupation or business outside of County or Town
- · Vacation outside of County
- Patient in hospital
- Unable to appear personally at the polling place on such day because of illness or physical disability.
- Will be detained in jail for an offense other than a felony or awaiting trial or Grand Jury action.
- Will be confined in prison after conviction for an offense other than a felony.
- Absence from the school district on the day of election by reason of accompanying or being with a spouse, child or parent who is an eligible district voter and is eligible for an absentee ballot due to one of the above or below listed reasons.
- · Confinement due to permanent illness or disability.

Voters may request an absentee ballot application by writing to Grand Island Central School District, attn: District Clerk, 1100 Ransom Road, Grand Island, New York 14072 or by calling 773-8801 between the hours of 8:30 a.m. – 4:00 p.m. All completed applications must be returned to the District Office at least 7 days before the vote in order for the ballot to be mailed to the voter.

Completed ballots must be received by the District Clerk's office by 5:00 p.m. on December 20, 2011.

**Voter Qualifications** 

Voter identification is required to vote.

# Frequently Asked Questions Asked Questions

## Why is the District having a bond vote?

Grand Island Schools is committed to providing a safe learning environment and well-maintained facilities for students and public use. Just as one's home ages and needs upkeep and repairs to keep it in good shape, so too, do our schools.

Many routine repairs and projects are funded within the annual District budget, with local taxpayers bearing the full cost. Large repairs and maintenance items, such as those included in this project, would have a major impact on the tax rate if included in the annual District budget.

A bond issue is a fiscally responsible alternative because the State reimburses 82.6% of the eligible cost and the expense is spread out over a longer period of time.

## How were the project's components chosen?

In early 2011, a state-mandated Building Conditions Survey (BCS) was submitted to the New York State Education Department (SED). A facilities committee was then formed, consisting of community members, District administrators, teachers and staff. Over a 9 month period, the Committee further defined and prioritized the structural, health and safety needs identified in the BCS. In addition to this process, District staff and administrators were preparing their list of educational based needs and priorities to keep our students competitive with others in the region and throughout the state.

This scope-definition process resulted in defining over \$100 million in structural, health, safety and educational needs throughout the entire District.

Both groups developed and presented their recommendations to the Grand Island Board of Education in late October. The Board decided to develop two propositions to cover the most immediate needs in the District. They also began formulating a plan to address future capital projects, ensuring that the District be financially prepared for such work.

## Is there a plan for the transportation facility?

Yes. The District is actively exploring economically feasible options to relocate/ rebuild the transportation facility. This plan is for both operational reasons and for the safety of our Sidway students, visitors and staff. The District is scheduling to present to residents a new building plan and location this spring. In anticipation of a new facility, the Board of Education has set aside \$800,000 from the District's reserve fund to address this important need at no or minimal tax increase.

#### Why two propositions?

The first proposition is for \$46,825,000 and is primarily planned for more critical scope items that will have to be done in the next few years as part of the State-mandated Building Condition Survey. In addition, this proposition addresses the most critical educational needs defined by the District's administration, staff and teachers. This work was grouped together to form a "No Tax Increase" proposition.

The second proposition focuses on two additional priorities – the high school auditorium and the District's most-used outdoor sports facilities. While this work was considered to be an important scope component that would have a positive effect on a large group of students/users, it could not fit within the "No Tax Increase" option.



Therefore, it is being offered to the District voters as a separate proposition.

#### When will the work take place?

It's expected that the State Education Department's approval for the project will be received by late 2012 with the bulk of work starting in summer 2013. It is anticipated that the project would be complete in 2015.

## What is the cost of the proposed project and how will it affect my taxes?

The total cost of both propositions is \$51,425,000.

The cost of Proposition 1 is \$46,825,000. This proposition will be paid for by a combination of State Aid funding, and the District's reserves. There will be no tax increase for this work.

The cost for Proposition 2 is \$4,600,000. This proposition will be paid for by a combination of State Aid funding and by a 2/10 of 1% increase to the District's taxpayers. This equates to approximately \$4.26 annually for a homeowner's \$100,000 full value.

## Isn't State Aid just my tax dollars too?

Yes, it is. The New York State Legislature has given all Districts in the state an opportunity to use tax dollars to enhance their communities through school building improvements and renovations. This is an opportunity to keep some of those tax dollars in our own community, working to improve the educational setting for our children and the public.


#### What if the referendum does not pass?

The building maintenance and restoration items are included in the project as response to the State-mandated Building Conditions Survey. Most are therefore considered to be necessary and would still have to be completed. If this work is performed outside of a capital project, it would be completed without the benefit of the State's aid, with local taxpayers bearing the full cost.

#### **BOND PROPOSITION NO. 1**

#### RESOLVED:

(a) That the Board of Education of the Grand Island Central School District, in the County of Erie, New York (the "District"), is hereby authorized to expend not to exceed \$46,825,000 to construct additions, alterations and improvements to all District school buildings and sites (the "Project"); (b) that a tax is hereby authorized in the aggregate amount of not to exceed \$39,495,000 to pay a portion of the cost of the Project, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education and, that in anticipation of such tax, bonds of the District will be issued, and a tax is also hereby voted to pay the interest on said bonds as the same shall become due and payable; and (c) that the balance of the cost of the Project shall be provided from moneys currently available in the District's 2008 Capital Reserve Fund, heretofore established following approval by the voters on May 20, 2008 (the "Fund"); and the expenditure of not to exceed \$7,330,000 of moneys in the Fund for said Project is hereby authorized and approved.



#### **BOND PROPOSITION NO. 2**

#### RESOLVED:

(a) THAT IN THE EVENT BOND PROPOSITION NO. 1 IS APPROVED, the Board of Education of the Grand Island Central School District, in the County of Erie, New York (the "District") is hereby further authorized to construct improvements to the Middle School/High School buildings and campus, and to expend therefor not to exceed \$4,600,000; (b) that a tax is hereby voted in the amount of not to exceed \$4,600,000 to finance such cost, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; (c) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the aggregate principal amount of not to exceed \$4,600,000 and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable; and (d) that if this BOND PROPOSITION NO. 2 is approved, it shall become effective only in the event that BOND PROPOSITION NO. 1 is approved.

#### **DEFINITIONS:**

## Understanding Property Tax

Here are a few definitions of frequently used terms to help make sense of property taxes.

PROPERTY TAX - Revenues received through the tax of district property. The calculation of property tax is computed by a process, which takes the assessed value multiplied by the assigned state equalization rate (full value). The levy is proportionately assigned to the full value amount.

#### PROPERTY TAX DEFINITIONS:

ASSESSED VALUATION - The official valuation of property for the purpose of taxation. The assessors of the district determine the valuation.

EOUALIZATION RATE - The ratio of assessed valuation to the full valuation of a city or town. The New York State Division of Equalization and Assessment determines the equalization rate. For example, an equalization rate of .50 would indicate that the local assessor is assessing real property at 50 percent of what is determined by the Division of Equalization and Assessment to be the full value of such real property.

EXEMPTION - A release from the obligation of having to pay taxes on all or part of the assessed value of a parcel of real property. When an exemption is granted, the rest of the owners of taxable property in the taxing unit must pay the taxes, which would otherwise have been paid by the exempt property.

FULL VALUATION - (also True Actual or Market Valuation) - The current markets value appraisal or estimate of what a property would sell for in a transaction between a willing buyer and a willing seller. The term is also applied to the result of dividing the assessed valuation by the equalization rate established by the New York State Division of Equalization and Assessment for the city or town(s) in which the school district is located.

TAX LEVY - The total dollar amount to be raised by property tax.





## If the 1st proposition doesn't pass, can the 2nd proposition pass?

No. Proposition 2 is contingent on Proposition 1 passing.

# The State of New York is threatening to cut school aid. How will this affect the project?

Typically, Building Aid has not been cut primarily because it does not solve the short term revenue issues experienced by the State of New York. However, for the first time in years, the State looks to be seriously considering a restructuring of their building aid formula. Any negative change would reduce the amount that is provided to the District for any capital building project.

We have been told by the State Education Department that, if changes are made, they would likely be enacted in 2012. By planning this project throughout 2011 and voting on December 20th, we are taking full advantage of the reimbursement formula by locking in our current aid rate to maximize every dollar given to us by the state of New York.

## Would a possible future property reassessment affect this project?

No. A reassessment would not affect the proposed capital project but it may affect your property tax. 
