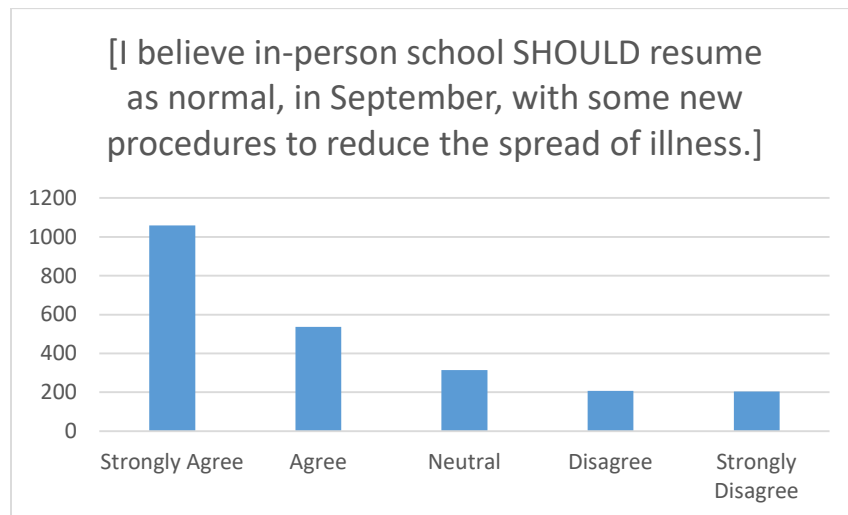
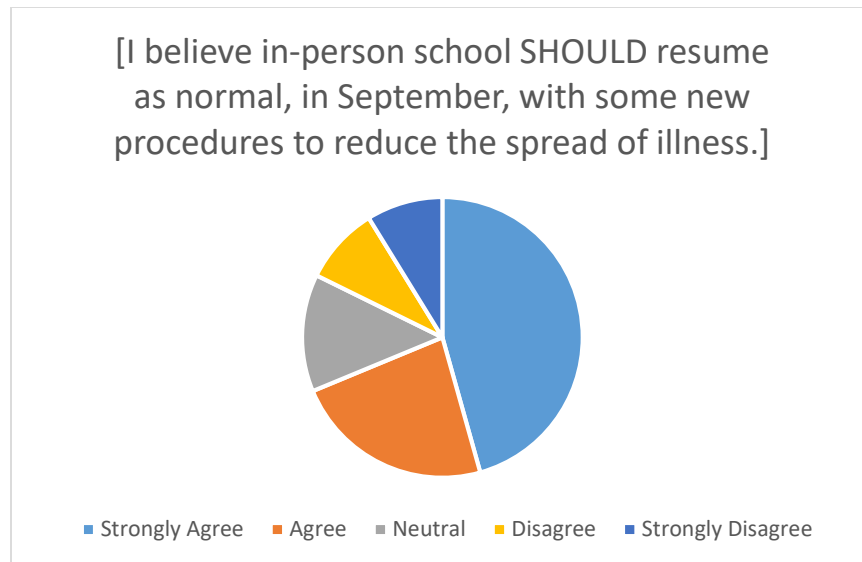


Grand Island Survey Regarding the Reopening of Schools in September

Summary

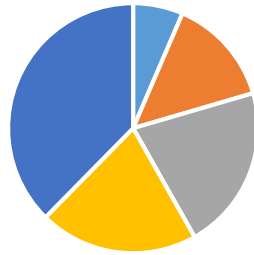
- 2320 total people responded to this survey.

Here is a breakdown of **all 2320 responses**:



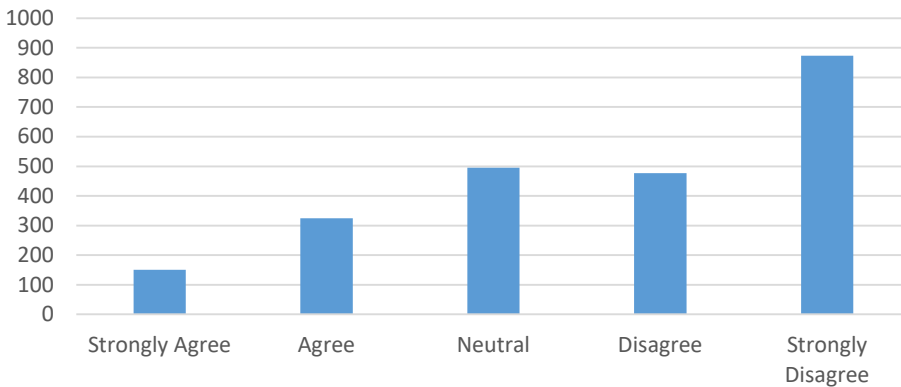

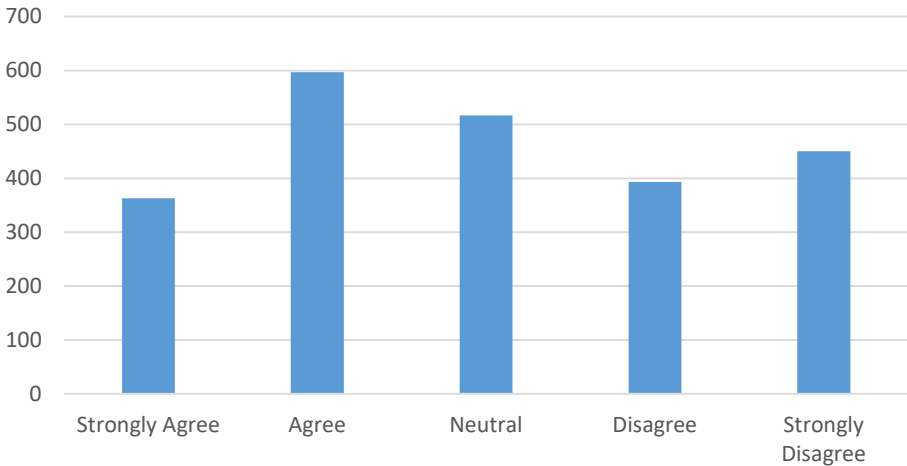

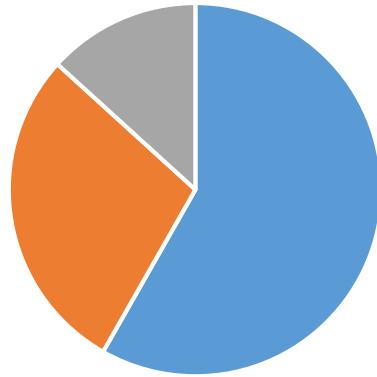

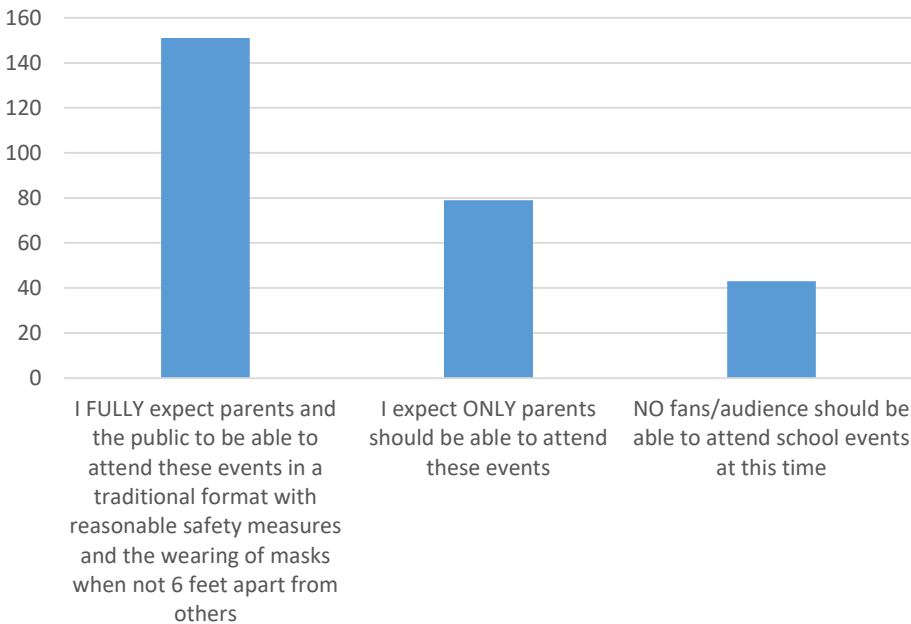
